# AERA - logbooks merging.

**Discussion** on merging of horses in the database. As we now have an online nomination system for rides, riders put in their own information. In some instances the horses in the data base appear twice. Some people do a ride before getting a logbook. If a rider misspells their horse's name, they may have a problem entering their horse into a ride. NSW does not merge horses in the data base. AERA advised that everything is Australia wide so NSW needs to merge horses into the database. There is no way of proving the ID of a horse on a blue card or a pink card. If a horse has a log book, it must be used.

Jax Barlow seeks a directive from the NSW SMC to merge horse records wherever necessary. This has not been done in NSW before.

**Resolved** to ask NSW delegates to get a directive from the AERA that NSW must merge all horses with the same names in the database. It mainly involves horses that have a log book.

# 104. Marketing - LH/TH-S

LH has had lots of hits on her internet page for NSW ERA. Still to do some more post Quilty reporting. Still more photos to put up.

Received a few emails about the Pony Club. Need to comply with any PC requirements and get the word **endurance** out there with the Pony Clubs. Get it on the Pony Club News. Try for a small advertising campaign. Strip ads with our logo, use a tag line and keep it out there. What we are aiming for is something national but currently its only NSW.

# Jax Barlow left the meeting at [7:58].

With the Intermediate membership drive, we had 17 at last count. Hoping for a lot more. Local promotion being done. Flyer sent to Pony Clubs. Kiwarrak entries still quite low. Usually don't get many in the 80 so depend on families who ride both days.

**Discussing** refunds. Riders did not like the refund policy decided on by NSW SMC, therefore the rides should be able to decide how they want to refund. This is causing people to be late in nominating. People should be able to have a full refund until 24 hours before the event. Ride organisers can design their own refund policy. They just need to include it on the ride booking form and advertise it. NSW ERA should not have a refund policy. It should be up to the ROs.

DK has a contact with a potential sponsor of barefoot boots. They could be interested in becoming a sponsor. They are open to collaboration. They advertise in equestrian magazines and spend a lot of money in advertising. Keen to get more involved with endurance. Advised where the new SMC was up to with promotion. Hopefully could get some gift vouchers. DK could be an ambassador for them and the sport. Would like us to do a survey of how many riders actually use boots and/or compete barefoot. Linda has discussed this with Talea. Need to get the survey approved.

CF would like to find a ride organiser who would hold a marathon of at least 240. Consider a new NSW marathon that we should support. Consider offering some financial support as is done for the NSW State ride. Alternatively consider sponsoring vets and chief stewards. WH advised that in the past he thought there was a financial contribution for Easter Carnivals.

Suggesting a new challenge for riders which could be called the '*Trilogy Trophy*'. Nothing to do with Shahzada. The Trilogy being the Quilty, NSW State Championship and a marathon of 240 or more.

CF elaborated on her proposal. Shahzada stays with the Big Three Award. The proposed Trilogy event would be a separate new event.

### PRESIDENT'S REPORT - MEETING 4TH JULY 2023

Congratulations to all NSW Riders who attended the TQ23. Our completion rate was high, and to the best of my calculations, NSW had a completion rate of 76.92%, which is above the total completion for the event of 71.98%. An amazing result considering the travelling distances and the heat and humidity at Imbil.

HWT - 8 Entries with 1 V/O

MWT - 30 Entries with 7 V/O

LWT - 20 Entries with 4 V/O

JNR - 7 Entries with 3 V/O

The Teams Event was a great success for NSW taking out 1<sup>st</sup> place in the State Representative Team Event, 6<sup>th</sup> Place in Restricted Teams Event and 6<sup>th</sup> Place in Unrestricted Teams Event with the NSW Juniors. Thank you to Darryl, Wayne and Avril for organising the teams. We looked very professional and proud to bring home the State Teams Trophy.

The Stirling's Crossing complex certainly has a great infrastructure that provides the "razzamataz". However, in appreciating the fact that the TQ23 ROC only had 6 months to put this event together, there were issues that should be addressed for Quiltys moving forward, including ensuring full internet access to sustain modern data entry and a modern GPS on course tracking system; ensure a Running Board and strapper calls for crew and strappers; and addressing the issue of operational course check points to ensure a fair competition is experienced by all.

I attended the Tom Quilty Members' forum at the Quilty. It was evident to me, the lack of understanding that in order to promote our sport, we need to address the issue of the Quilty being our "headline event" and that it is important that we provide an event that is attractive to sponsors and media in order to showcase our sport. At the moment, very few people outside of the immediate sphere of our sport know about the Tom Quilty Gold Cup or the sport itself. In my opinion, this starts at AERA level with the input of promotional and event management skills becoming increasingly important if the sport is to have an equestrian profile to attract members.

At our state level, we should be proud that Endurance NSW is at the forefront in promoting endurance riding. The social media platform is providing dividends which will hopefully translate into membership growth. Consequently, I believe we, as an SMC, should be confident to invest funds into our promotions portfolio.

# Vice President's Report

It was a pleasure to be part of the teams' coordinators with Avril Cummins & Wayne Hegarty. Avril did an amazing job organising the uniforms for the teams, individually wrapped for each rider. It was quite hard for Wayne & I to coordinate with everyone due to poor mobile & internet reception, but it all came together in the end. # TQ Wrap Up - Online Stats

We had an incredible online response over the TQ23 lead-up and during the event. The figures are phenomenal and going up daily. In the last 28 days we'd had 7,342 reach and 9,929 engagements. This will stabilise post TQ but we will follow up with some more "local hero" posts from Willow Vale between now and the next ride on the Calendar to keep the momentum going. The website has had 5,736 visitors in the 3 months since relaunch. I'd like to see more Ride Reviews added but understand they tend to go onto FB easily and it builds more direct engagement and feedback for the ROCs.

# **Pony Club - Discipline of the Month**

We have made contact with PC Australia about Endurance being included on their Discipline of the Month Program. We have an initial agreement and will be working on supplying the required content to them ASAP.

# **New Sponsorship Negotiations/Marketing Collaboration**

We have started initial discussions with a potential new sponsor who we believe we could collaborate with in other mediums in a targeted marketing programme.

# Half Price Intermediate Membership Promotion/Promotion in Zone 6

So far 17 new Intermediate Memberships have been sold. Zone 6 have 3 rides coming up between July and September so I've done some trial local promotions to around 20x Pony Clubs and Riding Clubs around the first ride base, Kiwarrak, promoting the 3 events and the half price Intermediate Membership. An email blast was also sent to all the JR Intro Clinic entrants. Some contact has been made with Kiwarrak Club from this and one new rider attended their last Committee meeting after seeing the promotions. The Want To Do Endurance Flyer advertising all 3 rides has been produced and also distributed locally and the promotion will pick up again before Johns River and Watagan Rides. ROCs have been advised we are happy to work with them around their Ride Bases in a similar manner.

# **Governance report**

Sharyn organised this grant.

We have \$6,500 from the government – things like teams, uniforms, junior uniforms – lot can be allocated as deliverables for that funding. Also \$2,000 within that that can be used for the website. Government asks how the deliverables were done for using this grant.

Sharyn will get profiles and concussion details to us this week, if possible. Make sure that we are on track for achieving these deliverables. First Aid could be part of the training. Pretty open.

# Horse Welfare report

Sourcing of swab stewards remains a major problem.

Three horses were subject to intensive treatment at the Tenterfield ride.

Two of these horses had no outcome (rest orders etc) but the third horse was euthanased some hours later, after transit from the base to home.

This horse (and another horse death in WA) was discussed at length by the AERA HWSC, and copies of the veterinary notes were obtained with permission of the owner.

It was deemed that the final outcome (euthanasia) would not have been altered. However, the administration of nonsteroidal anti-inflammatory drugs and sedatives at high doses almost certainly masked clinical signs. High doses of painkillers are also risk to kidney function. A recommendation has been made to AERA to update and circulate the 'crash card for endurance vets' and this will include advise to refer any horses treated at ride bases that may have ongoing problems on the journey home (colic cases) to a referral centre as early as possible. The final outcome may remain unchanged, but horse suffering and distress of owners will be minimised.

# **BIOSECURITY REPORT - June 2023**

No biosecurity plans were submitted for two rides; Central Ranges and Willow Vale.

I hope that Linda can put a regular post in the ROC ramble to remind organising committees to submit plans. AERA wants plans to be submitted with ride applications. Identifying all the roles at that stage may be difficult, so either a draft biosecurity plan needs to be submitted or the ROCS need to be chased up prior to the ride about the plans.

# AERA Online/Ride Database/ETS Workshop Report. Belinda Hopley

The Snowy Mountain Zone and ACT Endurance Riders Association hosted this workshop on the weekend 1<sup>st</sup> and 2<sup>nd</sup> July. Thirteen people attended with some having had some involvement with this but most having little or no knowledge. We were fortunate to be able to use the meeting room at Tom's workplace, as this enabled Tom to link his computer to a large TV screen. The ETS was also able to be set up indoors and use mains power.

Starting at 9.30am on Saturday, Tom McCormack gave us the background and knowledge to setup and manage their own ride setup for AERA Online, have a better understanding of ride day data entry procedures and get a working understanding of the ETS and how it integrates with the ride day data.

The AeraOnline module described the prerequisites required - setting it up, processing refunds and transferring nominations into entries. The advantages of using AERAOnline are accurate planning for vets, catering etc, all entries are prepaid and are automatically transferred into AERASpace, and all forms are electronically stored so no paperwork is required on the day. Any potential issues (membership, horse and rider age etc) are identified and can be sorted out prior to ride day.

The database processes greatly assist the RO personnel, from the pre-ride nominations (ie various nomination reports, horse and rider changes, etc) to ride day responsibilities. It can run reports very useful to the Chief Steward (such as Ride Setup and Starters Checklist) and the Ride Secretary (checking form completion, pre-ride info is all entered, accurate checkpoint lists, BC forms etc).

Both of these processes were very hands on, from creating our own ride, nominating for a ride and then transferring the nominations to entries.

All this was put to the test on Sunday when we entered a ride that Tom had setup. Tom then took us through the data and physical requirements for ETS setup required for a ride. We then "saddled up" and rode, with various issues happening along the way, such as leaving before due out time, coming in late losing the RFD tag etc. The remote data entry using the IPad was also demonstrated. This allows the vetting data to be entered into the logbooks at the vet area and replaced back into the logbook box, minimising lost logbooks and leaving the office staff free to do the myriad of other tasks required.

This system does make it much easier for ride organisers, and Tom's knowledge and relaxed manner gave everyone the information required and a greater sense of confidence in using the system.

The Snowy Mountain Zone Mountain Zone and ACT Endurance Riders Association are anticipating running this workshop again in the New Year. Participant numbers will again be restricted as even with Kim Stephens assisting Tom with the ride database module, he was in demand. We sincerely thank Tom McCormack for his help and patience and the NSWERA SMC for their support and providing lunch and teas. All the participants were very grateful for the workshop and Tom's support. We thank them for their interest and support of our sport and making out workshop a success!
